# Constitution of World Sports Karate Federation (WSKF)

#### **Object 1 Organization and Name**

The World Sports Karate Federation, abbreviated as WSKF, is a non-governmental, non-profit, self-governing educational organization, which is registered in India.

#### **Object 2 Origins and Status**

- 2.1 The WSKF is the non-profit international organization for the karate and martial arts community, and is open to all karate institutions, karate authorities, and individuals.
- 2.2 WSKF has a partner status with INOC and its members. WSKF main aim is to promote Sports Karate throughout the world and use of new kata rules and kumite rules.
- 2.3 WSKF was founded in 2005 in India by Shihan T.Pandiraj and Implemented by Mohamed Seraj Ansari and it has official managed and run by International Non-Olympic Committee.
- 2.4 WSKF is supporting all karate organization systems, norms and regulations

#### **Object 3 Mission and Aims**

- 3.1 To promote **Sports Karate game internationally** and take whatever measures are necessary to this end.
- 3.2 To represent the interests of its members at International level with regard to the karate authorities, the mass media and the public, in as far as this is not left up to the members.
- 3.3 To promote sports karate rules in all national internationally.
- 3.4 To monitor and ensure the keeping of the existing system-specific rules, to develop a set of standard rules and to draw up an International event Calendar.
- 3.5 To encourage all **institutions and individuals members** can connect in professional communication in the field of sports karate/martial arts.

#### **Object 4 Membership**

- 4.1 There shall be one types of membership, National Membership
- 4.2 All membership may be awarded, by decision of the President.
- 4.3 WSKF committee (president/Secretary) will have rights to cancel the membership at any time.
- 4.4 WSKF membership rights shall be open to all but those who are in good standing with the organization.
- 4.5 Membership fees shall be resolute by the Corporate Leadership and are not refundable.

## **Object 5 The Organization's Business Structures**

5.1 WSKF's structures as follows

Corporate leadership

- 1. President
- 2. Vice-President
- 3. Secretary General

Operation and Supportive Leadership

- 1. Technical Committee
- 2. Referee Committee
- 3. Sports Committee
- 4. Medical Committee
- 5. Tournament Committee
- 6. Regional Committee
- 5.2 Meetings of the bodies may take place face-to-face or electronically.
- 5.3 The results and decisions of meetings of the bodies shall be published within 25 working days
- 5.4 WSKF will not provide any financial support for members.
- 5.5 The President and Secretary General will take part in all meetings of the bodies.
- 5.6 Corporate/Supportive Committee appointment will decided by President and Secretary General.

#### **Object 6 The Corporate/Operation/supportive Committee**

#### Part a) Role, Responsibilities, Structure

- 6.1 INOC Founder is the accountable for making policy decisions in conflict with WSKF's mission and constitution.
- 6.2 The responsibilities of the Corporate/Operation/Supportive Committee shall have good relation with WSKF.
- 6.3 The role of the corporate committee members usually serve on a Voluntary basis which helps to WSKF development and have a responsibility of appointment approvals.
- 6.4 An operation/supportive committee plays an important role in developing WSKF globally. This role may be compromised all observers do not follow certain rules that should guide their conduct during their mission and Observers must not interfere with the work of corporate committee. Their mandate is not to supervise correct mistakes

or resolve local conflicts, but to observe.

6.5 The WSKF supervisory committee shall be consist of three designated members.

# Part b) Appointment Procedure

- 6.5 Corporate/Operation/Supportive Committee appointment shall be decided by INOC Founder.
- 6.6 The President and Secretary General shall be permanent members.

# **Object 7 Announcements with Members**

7.1 WSKF's all Information/Announcement shall be displayed in website.

# **Object 8 Changes to the Constitution**

- 8.1 A proposal/membership must be submitted to the Secretary General. Secretary General will submit to president. The proposal may be made by a National Member or committee member.
- 8.2 A proposal made by the Operation/Supportive Committee must be supported by president.
- 8.3 A proposal to amend the constitution shall be announced to WSKF members within two months of its receipt by the President/Secretary General. On the advice of the President, the Secretary General shall publish to members.

## **Object 12 Dissolution of the Council**

- 12.1 The Council can only be dissolved by an INOC founder.
- 12.2 A decision process on will be undertaken by president/general secretary.
- 12.3 The Judicial should be in India not in other country. If anybody take legal action against this organization the court should be in India not in other Country.
